At 16:22:59, Detective John Williams attempts to open the front passenger side door but unable to do

At 16:23:00, the vehicle backs up and Detective John Williams moves with the vehicle.

At 16:23:03, Detective John Williams yells: "Shut it off". The tan vehicle then drives around his patrol vehicle.

At 16:23:06, the tan vehicle strikes Officer Nicholas Kehoss' vehicle and continues to travel in the parking lot onto the main road.

4. That on October 24, 2023, I reviewed the BWC recording of Office Nicholas Kehoss. All times are to the seconds, retrieved from the BWC embedded time. The video's timeline can be summarized as follows: The Camera was activated on October 14, 2023 at approximately 16:22:44 hours. The first 30 seconds do not have audio. Officer Nicholas Kehoss can be seen driving his police vehicle at up to 69 mph with the emergency lights and siren activated.

At 16:23:34 hours, Officer Nicholas Kehoss activated his radio and informs dispatch: "Crash, crash, crash, on the on-ramp, bail, bail".

At 16:23:40, Officer Nicholas Kehoss opens his driver side door.

At 16:23:42, Officer Nicholas Kehoss exits the police vehicle. The operator of the tan sedan later identified as Jarell Day (DOB: 10/10/1990) is seen in the camera view running away.

At 16:23:42, Officer Nicholas Kehoss is running and heard yelling: "Better fuckin stop, Better fucking stop".

At 16:23:48, Officer Nicholas Kehoss draws his yellow Taser, Electronic Weapon from the holster.

At 16:23:48, Officer Nicholas Kehoss switches the Taser's selector lever from safe to fire (armed).

At 16:23:49, Officer Nicholas Kehoss aims his Taser at the suspect.

At 16:23:49, the suspect can be seen stopped in tall vegetation with both his hands in the air looking at Officer Nicholas Kehoss.

Officer Nicholas Kehoss can be seen approaching the suspect who is stationary with both hands' waist high away from his body and with open hands.

At 16:23:50, Officer Nicholas Kehoss yells: "On the ground, on the ground".

At 16:23:50, Officer Nicholas Kehoss fires his Taser aimed at the suspect.

At 16:23:51, both prongs are seen to strike the suspect who is observed to react to the taser by crossing his arms with an expression on his face.

At 16:23:51, Officer Nicholas Kehoss fires his Taser again aimed at the suspect.

At 16:23:51, the second set of prongs are seen to effect the suspect and begins to fall to the ground onto his back. The suspect can be heard yelling: "Oh, shit, I'm sorry".

At 16:23:53, Officer Nicholas Kehoss informs dispatch: "Taser, taser, taser, one down".

At 16:23:56, Officer Nicholas Kehoss yells: "On your stomach".

At 16:23:58, Officer Nicholas Kehoss yells: "On your fucking stomach now". The suspect turns onto his stomach and states: "I'm sorry". Officer Nicholas Kehoss continues to yell and point to the ground: "On your fucking stomach now".

At 16:24:01, the suspect can be seen turning slowly to his stomach while looking at Officer Nicholas Kehoss who pulls the trigger of the Taser and activates it again.

At 16:24:02, the suspect is heard yelling: "Yeah, ok."

At 16:24:02, Officer Nicholas Kehoss steps forward and stands over the suspect while yelling: "On your fucking stomach". Officer Nicholas Kehoss then touches the back of the suspect and yells: "How many fucking times do I have to tell you"?

At 16:24:06, the Taser disengages, and the suspect is heard stating: "I'm done, I'm done sir, I'm done".

At 16:24:09, Officer Nicholas Kehoss is seen pushing the back of the suspect to the ground while yelling: "Put your fucking hands behind your back".

At 16:24:11, Officer Nicholas Kehoss grabs the suspect's left arm and brings it to the back of the suspect who states: "sorry, sorry".

At 16:24:13, Officer Nicholas Kehoss is seen to let the suspect's arm go, and talks on his portable radio: "John, you still have one in the car, I got this guy taken care of." The camera is seen to aim towards the other officer arriving on scene.

At 16:24:18, the suspect states: "Officer, I am sorry, I don't know what the fuck happened".

At 16:24:19, Officer Nicholas Kehoss is seen grabing the left arm and left collar bone area of the suspect and bring the arm to the back of the suspect.

At 16:24:19, Officer Nicholas Kehoss puts his right hand over the left face of the suspect and pushes it into the grass and states: "Shut the fuck up".

At 16:24:21, Officer Nicholas Kehoss releases the suspect's head and states: "put your fucking hands... you're getting another ride. You're getting another fucking Taser if you don't put your hands behind your back". The suspect is heard saying: "I got you, sorry sir, I don't know what happened". At 16:24:26, Officer Nicholas Kehoss is holding the suspect's left arm in the back of the suspect and

holding the right arm and pulling up on it.

At 16:24:29, Officer Nicholas Kehoss releases both arms of the suspect while he states: "Put your... you are getting another fucking ride". The suspect is heard saying: "No, no, please".

At 16:24:30, Officer Nicholas Kehoss engages his Taser by pulling the trigger.

At 16:24:32, Officer Nicholas Kehoss drives the Taser into the upper back of the suspect and continues to push it downward. The suspect is observed holding his left arm behind his back and the right arm next to him. The suspect is heard saying: "stop, stop".

At 16:24:35, the Taser disengages, and Officer Nicholas Kehoss says: "Put your fucking hands behind your fucking back now"! While Officer Nicholas Kehoss yells, his is still holding his Taser in his right hand, aiming it at the back of the suspect and pushing it into the back of the suspect.

- 8. That the according to the Use of Force Policy and Procedures of the Naugatuck Police Department Police officers must use only the minimum level of force necessary to achieve a lawful purpose. Any use of force must be reasonable, proportionate to the threat, and employed in a manner consistent with this policy. "Active Resistance" means any physical act undertaken by a subject against an officer that could reasonably impede or defeat the officer's lawful attempt to gain control of the subject. 12.1.5 states that an officer may use less lethal force when reasonable and necessary to overcome the use or imminent use of force against an officer or a third person. The level of less lethal force used must be proportionate to the threat, perceived or existing. Less lethal force may not be used against any person engaged in passive resistance.
- 9. That Officer Nicholas Kehoss was hired as a Police Officer with the City of Naugatuck in 2011. Since his hire, he has attended several training sessions where he was taught how to use a Taser and trained on the Use of Force policy. On December 6, 2022, Officer Nicholas Kehoss attended training on De-escalation and Taser 7 transition course. On January 18, 2023, Officer Nicholas Kehoss attended Use of Force Training. On February 28, 2023, Officer Nicholas Kehoss attended training on Defensive tactics, OC, Baton and Handcuffing.
- 10. That the PowerDMS training records indicate that Officer Nicholas Kehoss read and signed the Conducted Electronic Weapon (CEW) on January 4, 2023 at 0942 hours and the Use of Force policy on June 8, 2023 at 0818 hours.


