OVERVIEW OF INCIDENT

On the above date and time, Miller was observed operating his vehicle with a suspended registration for failing to maintain insurance requirements. Subsequent investigation revealed that Miller was in possession of crystal methamphetamine in both rock form and liquefied into a hypodermic needle prepared for injection. He was transported to Troop L in Litchfield where he was processed and released on a \$10,000 non-surety bond. He is scheduled o appear in Waterbury Superior Court on 2/23/2024.
